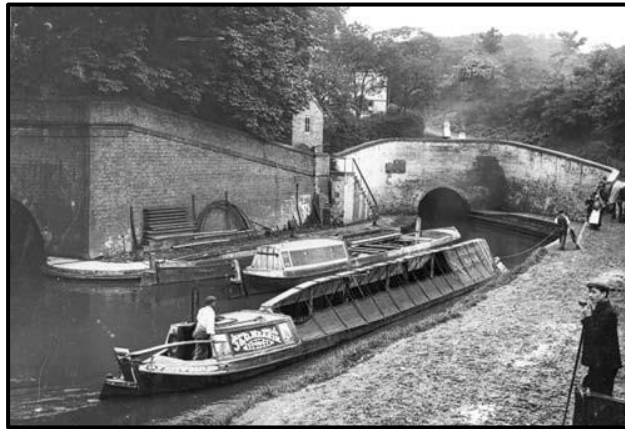

but the parallel "Telford" tunnel was restored and reopened in 1977 after our 3-year campaign.



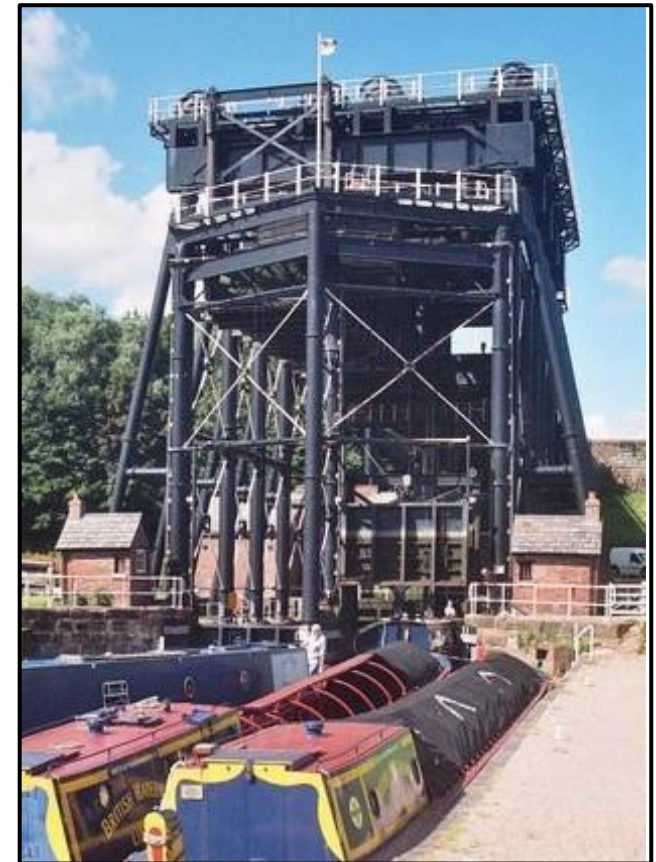

GIFT AID DECLARATION
